1.	RECO	RECOMMENDATION		
1.1	from 1	To extend the current contract with TTC Group Ltd for a one month period from 1 June 2014 to 30 June 2014, in accordance with paragraph 125 of the Manual of Governance.		
2.	INTRO	INTRODUCTION & BACKGROUND		
2.1	In December 2008, Gwent Police awarded a contract for the Provision of Driver Education Offender Rehabilitation Scheme(s) Speed Awareness, for a period of three years with an option to extend for an additional two years, awarded annually. Currently, the contract is in the first month of a two month extension.			
2.2	The contract was awarded for the Provision of Driver Education Offender Rehabilitation Scheme(s) Speed Awareness to a supplier who could provide the force with the requirements of delivering services to members of the public who were required to attend the courses.			
2.3	The contract is currently utilised by Gwent, South Wales and Dyfed Powys Police.			
2.4	The contract was awarded in accordance with EU Directives and Gwent Police Authority's Standing Orders, with the successful supplier selected based on the Most Economically Advantageous Tender. The award criteria of the tender process included Rates and Charges, Specification Response and Presentation.			
3.	ISSUES FOR CONSIDERATION			
3.1	The contract is still required to be utilised by the three forces mentioned in 2.3 above for an additional one month period after the current expiry date of 31 <sup>st</sup> May 2014. This extension is required to allow for the incumbent supplier to continue delivering the services required by the public, who need to book and attend course under the scheme. During the remainder of time up to the current expiry date and the additional one month period, it is anticipated that the approval of the new contract be granted, all suppliers tendering to be notified of the outcome, ten day standstill period served in line with EU Procurement Directives and a handover period to the successful supplier.			
3.2	The procurement process for the new contract has been completed with the successful supplier identified and an Office of the Police and Crime Commissioner Report submitted for approval.			

4.	NEXT STEPS		
4.1	On approval of this report, contract extension documents will be issued to the incumbent supplier, where they will be signed and returned to the Commissioner.		
5.	FINANCIAL CONSIDERATIONS		
5.1	The value of the extension for this contract has no cost to the Commissioner. The payment of courses is made directly to the supplier by the delegates who will be attending the courses. It is envisaged that there will be approximately 4,200 delegates attending courses in the one month period.		
5.2	The supplier has confirmed that they are happy to extend for the additional one month period and have confirmed that all prices will remain the same for the period.		
6.	PERSONNEL CONSIDERATIONS		
6.1	As part of the extension there would be no staffing/personnel implications.		
7.	LEGAL IMPLICATIONS		
7.1	This report has been submitted in line with the EU Directives and the Scheme of Consent.
