2.	INTRODUCTION & BACKGROUND
	Treasury Management covers borrowing, investing, banking and cash flow
	management. This report fulfils four key annual legislative requirements:
	(i) The setting of the Prudential Indicators relating to Capital Expenditure;
	(ii) The Minimum Revenue Provision Policy;
	(iii) The Treasury Management Strategy; and
	(iv) The Investment Strategy in accordance with the Welsh Government's
	Guidance on Local Government Investments.
	The report also seeks approval for twelve Treasury Management Practices.
3.	ISSUES FOR CONSIDERATION
	The Commissioner is required to adopt and comply with the Chartered Institute
	of Public Finance and Accountancy (CIPFA) Prudential Code for Capital
	Finance in Local Authorities (2011 (as revised)) and the CIPFA Code of
	Practice on Treasury Management (2011 (as revised)). The Treasury
	Management Strategy 2021/22 to 2023/24 (Appendix A) and the Treasury
	Management Practices (Appendix B) are submitted for approval in compliance
	with the Codes.
4.	NEXT STEPS
	The Capital Prudential Indicators demonstrate that the Capital Programme is
	affordable, prudent and sustainable and it is essential that the Commissioner is
	satisfied of this situation prior to formally setting the Budget and Council Tax
	Precept for 2021/22.
5.	FINANCIAL CONSIDERATIONS
	This is a financial report required prior to setting the budget and Council Tax

	Precept for 2021/22.
6.	PERSONNEL CONSIDERATIONS There are no additional staff requirements stemming from this report.
7.	LEGAL IMPLICATIONS Approval of the Treasury Management Strategy by the Commissioner is a statutory responsibility.

9.	<b><u>RISK</u></b> Treasury Management can never be risk free. In borrowing, the risk is that interest payable might be higher than necessary and in lending there is the risk of default on repayment and the risk that a better rate of return could have been achieved. Adherence to the CIPFA Code of Practice on Treasury Management is best practice in terms of balancing risk and return.
