2.	INTRODUCTION & BACKGROUND				
2.1	Gwent Police (GP) facilitated a mini competition under the National Procurement Service (NPS) framework (ref NPS-PSU-0010-14) on behalf a South Wales Police (SWP) and Dyfed Powys Police (DPP). The contraction commenced on 1 December 2015 for an initial term of three (3) years until 3 November 2018, with an option to extend for twelve (12) months until 3 November 2019.				
2.2	The extension option was utilised but the full 12 months was not taken. The extension was taken and made to co-terminate with the NPS framework of 15 th November 2019. The NPS decided to terminate the framework earlie than planned.				
2.2	To date, SWP have not utilised this contract, they will continue to use temporary staff sourced from their in-house recruitment pool. DPP have confirmed that they wish to be included within our extension request.				
3.	ISSUES FOR CONSIDERATION				
3.1	The framework ends on the 15 th November 2019, therefore extending this contract will be at GP risk. There has been a delay completing the required documentation by an internal GP business area. This extension will allow further time for the business area to provide the complete requirement documentation in order allow a compliant tendering process to be completed.

4.1	On approval of the report, a contract extension will be issued to the currer supplier and signed by both parties.		
4.2	The contract will be updated on the 'BlueLight' database and Dyfed Powy Police will be informed.		
5.	FINANCIAL CONSIDERATIONS		
5.1	The incumbent supplier has confirmed that they will apply the current rates and margins. Pricing will only change to reflect legislative changes or annual increments from both Forces.		
5.2	The estimated cost of the extension period is: 1. Gwent Police - £927,152 2. Dyfed Police - £6,159.

6.1	As part of this extension there will be no internal staffing/personne implications above and beyond the normal requirements of the current service provided to the Commissioner.

7.1	The proposed extension period is not provided for under the terms of the original Framework and subsequent GP contract and therefore any furthe extension is not permitted under the Public Contract Regulations (PCR). This would therefore amount to an illegal direct award (please see Risk section 9).
