# MINUTES OF MEETING HELD ON 11TH NOVEMBER 2014

The minutes were agreed to be an accurate record. 1.

### **CUSTODY UPDATE**

Detective Inspector Steve Hudson (SH) provided the group 2. with the custody update on behalf of Inspector Dave Stroud (DS).

> SH confirmed that the transition to the new operating model had taken place and was working efficiently with all custody staff working on a four on, four off rota.

> SH updated the group that he had contacted the Head of Estates and Facilities regarding the buzzers at Ystrad Mynach but at the time of the meeting no response had been provided. Mrs Maria Chapman (MC) confirmed she had spoken to the Head Of Criminal Justice, Data Management And Information Security Department and was assured the work would be completed by the end of May 2015.

Micah Hassel and Mark Smith were confirmed as the new custody inspectors.

A number of issues were raised following SH's update. Mr Brain Williams (BW) queried that in Newport there is no bell SH/DS when a buzzer is pressed but there is a light. SH confirmed he would look into this after the meeting.

BW also raised that there was increasing delays following visits in getting forms signed by the custody sergeant. It was confirmed that as long as no issues were raised visitors could get their reports signed off by the custody detention officers (CDO).

Mr Anthony Angell commented on the appearance of the Newport custody suite stating that there is very little space for the visitors to write up their reports as the rooms are being MC used for storage. MC agreed to raise the issue with estates.

### **SCHEME UPDATE**

3. MC provided the group with the scheme update.

> The group were made aware that Miss Ivy Forkin had tendered her resignation as an independent custody visitor. The group all agreed that she will be greatly missed.

> A recruitment drive for independent custody visitors was confirmed to take place over the summer.

> All members were reminded to randomly check custody records to ensure an independent evaluation of the custody process.

> MC made the group aware of the new section 136 mental health concordat which was close to being signed. This would mean that people with mental health issues will not be detained in custody but be taken to a place of safety.

> Mr Arthur Elliott (AE) asked for an update on the pilot scheme where nurses are on call with officers. MC confirmed that the pilots were still on-going.

> MC confirmed that a training session will take place before the 13<sup>th</sup> August meeting. Visitors were asked what topics they would like to cover in training. Topics identified were mental health in custody and youth custody. The training would begin at 1pm until 3pm when the Independent Custody Visitor Association (ICVA) meeting would take place.
