Subject	Serious Violence Prevention Funding 2019/20 for Barnardo's	
Summary	To record the decision to provide grant funding to Barnardo's to deliver Serious Violence Interventions as part of the Serious Violence Prevention Wales Project during the 2019/20 financial year.	

DECISION

- 1. The Police Reform and Social Responsibility Act 2011 provides under sections 9 and 10 that the Police and Crime Commissioner for a police area makes crime and disorder grants and acts in co-operation with responsible authorities and makes arrangements with criminal justice agencies for the exercise of functions so as to provide an efficient and effective criminal justice system for the area. This provision was further supplemented by virtue of the Anti-Social Behaviour, Crime and Policing Act 2014, which provided specific arrangements for the provision of funding for victims.
- In 2018/19, a collaborative all Wales bid, led by the Police and Crime 2. Commissioner for South Wales, on behalf of the four Welsh Police and Crime Commissioners (South Wales, Gwent, Dyfed Powys and North Wales) was submitted to the Home Office Early Intervention Youth Fund (EIYF). A total award of £1.2m to deliver the Serious Violence Prevention Project Wales (SVPPW) was made by the Home Office from the EIYF for the financial years The SVPPW is delivering a regional, multifaceted 2018/19 and 2019/20. approach to understanding and tackling the root causes of serious violence through early intervention and prevention, with children under the age of 18. As part of the project, Serious Violence Coordinators are being appointed in each Force Area. Furthermore, direct intervention is being delivered by third sector organisations, including St Giles Trust, Crimestoppers, Street Games (in Dyfed Powys, South Wales and North Wales) and Newport Live - Positive Futures (in Gwent), to empower and educate children and young people about crime and criminality and to divert children and young people away from the risk of exploitation and serious organised crime.

The intended outcomes for children and young people of the SVPPW are:

- Young people will be able to identify positive aspirations and goals;
- Young people will feel safer;
- Young people will have improved well-being; and

Young people will be better informed as to where to seek support.

The Home Office EIYF grant is held by the Police and Crime Commissioner for South Wales. A Collaborative Agreement outlines the roles and responsibilities of the partners named in the Home Office bid in delivering the SVPPW Project. An allocation of £106,607 has been made available to the Gwent Police and Crime Commissioner for 2019/20. This includes £45,000 for a Serious Violence Coordinator, an Enhanced Service Intervention Budget of £40,860 and an allocation of £20,747 for diversionary activity. A commitment was made in the bid for each Commissioner to match fund 50% of the Enhanced Service Intervention Budget within the 2019/20 financial year. In Gwent this equates to a commitment of £20,430, from the Police and Crime Commissioner for Gwent.

3. My decision log PCCG-2019-033 outlines my decision to provide £45,000 to Torfaen County Borough Council to employ a serious Violence Coordinator and £27,886 (£20,747 from EIYF grant and £7,139 from my Commissioning budget) to Newport Live to deliver intervention to young people affected by serious violence.

Barnardo's was invited to submit a proposal for the Enhanced Services Fund which remained unallocated. This proposal was reviewed and considered by the EIYF Project Board on 11th September 2019. After reviewing the proposal the Board recommended the proposal be accepted.

4. I have considered the requirements under both Acts of legislation, the requirements of the grant agreement, the recommendation of the EIYF Project Board and assessed the impact on my Police and Crime Priorities for Gwent and have decided that I will provide non-recurrent funding, awarded predominantly from the Gwent allocation of the Home Office EIYF grant, to:

Barndardo's £60,000

 To expand the Newport Divert Service by employing two additional full time practitioners and increasing the Children's Services Manager's hours by 1 day per week between 1st October 2019 and 31st March 2020. The Children's Services Manager role will be specifically ring fenced for delivery across Blaenau Gwent, Caerphilly, Monmouthshire and Torfaen.

The allocation available from EIYF grant for Barnardo's delivery is £40,860, therefore a further £19,140, out of the £20,420 match funding committed, will be made available from my Commissioning budget.

5. The arrangements for each award will be set out in a Grant Agreement which includes appropriate terms and conditions, purpose of the award and payment, monitoring and reporting arrangements.

In order to monitor the progress of funded projects, and provide reassurance that funding allocated is effectively meeting Policing Priorities in Gwent, as outlined in the Police and Crime Plan, and the requirements of the Home Office EIYF grant, the grant recipients are required to complete a mid year and an end of year monitoring report which will require the following information to be provided:

- Project Activity;
- Project Outputs;
- Project Outcomes;
- Breakdown of financial expenditure:
- Risk; and
- Leaming.

Grant recipients will be required to accept the terms and conditions of the grant, which will be outlined in a Grant Agreement and Grant Offer Letter by signing and returning the relevant documentation prior to any funding being released.
