| Figure 1. Proportion of Hate Crimes by Strand Consistent with previous years, race related crimes account for most hate crimes (56%, n=551). There were 623 racially motivated hate crime occurrences recorded in 2018-19, a rise of 12% from 2017-18 (n=555). In 2019-20, these crimes declined by 12% to 551, more consistent with 2017-18. In the first half of 2020-21 race hate crimes are 54.3% of the total crimes recorded to date. In Q1 and Q2 of this current year 77 disability hate crimes have been recorded which is 13.03% of all hate crimes recorded. This may ultimately be down on last year's totals at the end of the year- What is the force's understanding of the reasons for the changes in reporting trends? | There are many factors affecting the first half of 2020/21 figures notwithstanding the Covid pandemic. The number of incidents being affected by the late night and pub economy being restricted Places of worship were also closed for much of the first half of the year which may have had an impact on the number of race / faith incidents taking place. As a force we have worked with many disability organisations over the last year including Mencap Cymru and learning disability wales in an attempt to increase reporting of disability hate crime. Our work may affect the increase in incidents reported to us during his time. Anecdotally, we believe that some hate incidents have originated from neighbour disputes aggravated by the lockdown restrictions. |

| | | 4.5 Interfaith Network The Diversity and Inclusion team have established an Interfaith Network across Gwent. (Police and Faith Together) Have there been any meetings since the Network was created? Is there anything to feedback for this reporting period? | The Network has met 3 times since its inception – the last being only a week ago. Hate crime is just a small but important aspect of the work of the Network. Part of the rationale is to build general relations with our faith communities on several issues. The pandemic has interfered with that in that we can't develop face to face relations and online methods don't allow often to build dynamic relations with the faith places of worship. However, our message on hate crime is to report to us using the network as a channel if no other traditional and formal method is considered. Post Covid we intend to focus on hate crime (and Stop and search) to gain trust and confidence from our communities in our actions on these two matters |
