1. RECOMMENDATION

That confirmation is provided for the appointment of the final two members of the Joint Audit Committee (JAC).

2. INTRODUCTION & BACKGROUND

The Financial Management Code of Practice for the Police Service of England and Wales requires that a Police and Crime Commissioner and Chief Constable establishes an Independent Audit Committee and recommends that this should be a combined body. Following an open recruiting process three of the five independent members of the JAC were appointed in September 2012 with the first shadow joint committee held on the 20th November 2012.

The three initial appointments were approved by the Police and Crime Commissioner and the Chief Constable on the 13th December 2012.

3. ISSUES FOR CONSIDERATION

A further recruitment process was undertaken during February and March 2013 in order to recruit two further members.

One applicant was shortlisted and interviewed with another applicant from the initial appointment process also being re-considered; both of these applicants were successful.

4. NEXT STEPS

Confirmation of the appointments to the JAC of Mr Jonathan Sheppard and Mr Geoffrey Hughes for a period of five years until 30th September 2017 is requested.

5. FINANCIAL CONSIDERATIONS

Members of the JAC are remunerated at the rate set by the Home Office for Police Appeals Tribunals, i.e., £104.50 for meetings lasting up to 4 hours and £211.50 for meetings lasting more than four hours. No payments are made to cover reading time prior to meetings.
